I. Call to Order

II. Opening Prayer

a. Rachel Zippwald opened the meeting with prayer.

III. Ministry Team Highlight

- A Highlights of Adult Spiritual Formation were shared by Linda Woodbury

 1. The team is currently involved with Sunday morning Adult Education, Alpha, Disciple,
 Monthly Prayer Gatherings and Cursillo.
 - 2. The team has lost Pastor Joe and Karen Quane (to Grace Visual Arts) but are adding new members to the team. Bob Eggink will be leading the Sunday Spiritual Gifts class one week.
 - 3. Linda emphasized patience in growing the team.

IV. Council Consent Docket

- a. Minutes of the August 28 council meeting were presented. **Motion was presented, seconded and approved.**
- b. Adult Spiritual Formation minutes from September 10 were presented
- c. Reaching Out team minutes were presented
 - 1. Discussion ensued regarding S.H.I.P. being invited back to Grace next year. The Reaching Out team was insistent that S.H.I.P. return. Problems with them this year were cited, including a lack of night supervisors and the volunteers not being fully prepared. Council felt that there are too few volunteers to run the program. It was suggested that the team provide a proposal to the council, much like the one done by Good News Ministry when they began. Rachel will provide a copy of the Good News proposal to the Reaching Out team.

Motion Presented: Reaching Out Team will provide the Grace Council with a proposal setting out the criteria necessary to make S.H.I.P. viable at Grace next year. The proposal will be ready to present at the January council meeting.

- c. The preschool enrollment is still fluctuating as the year starts. After the first month or so, enrollment will settle down to a normal pattern.
- d. The school is beginning the periodic re-accreditation process which happens every six years.
 - 1. Janie and staff are preparing all necessary reports and documentation to present to the accreditation team that will visit the campus in the spring of 2014.

VIII. Pastor's Report

- a. Pastor Chris has finished the sermon series on "Answering God's Call". Beginning this Sunday Bishop John Bradosky will begin the new series on "Covenant and Kingdom" which will carry us through to Lent.
- b. Pastor Chris and Beth attended the 3DM leader/spouse retreat last week
- c. Pastor Chris and Beth are team teaching the middle school bible class at our school Beth teaches Tuesday and Pastor Chris teaches Thurs which gives Chris more time in his schedule to prepare for preaching.
- d. Alpha has started. Grace is partnering with Hope this session. Pastor Chris and Pastor Paul Finley
 - are rotating weeks doing the teaching. Debbie Graves did a phenomenal job coordinating Alpha.
- e. Pastor Joe's departure as announced. People were sad but the news was well received.
- f. The council will coordinate a farewell barbeque to honor Pastor Joe on October 28th.

- "Grace Care" and "Grace Life" will be listed as separate headings in the annual budget.
- The office staff in conjunction with the Senior Pastor will provide coordination and oversight of the ministries listed under "Grace Care."
- An active elder on the Council provide coordination and oversight of the ministries listed "Grace Life."
- The following ministries listed under "Grace Life" have leadership and support are therefore make-up the current "Grace Life" ministry team:

 - OK Club (D. Brundage)
 - Women's Ministry (Joyce Eggleston)
